#### **1 Sharaxaada**

## **3 Baaxada Weydiinta**

  - (iii) safarkiisa ee gudaha New Zealand, iyo caalami ahaan; iyo
  - (iv) sida uu u helay shatiga qoriga, hubka, iyo rasaasta; iyo
  - (v) isticmaalkiisa warbaahinta bulshada iyo warbaahinta kale ee onleenka; iyo
  - (vi) xidhiidhadiisa dadka kale, haddii uu ku jiro New Zealand ama caalami ahaan; iyo
- (b) wakaaladahee qeybta Gobolka quseyso ayaa wax ka ogaa shaqsigaan iyo howlahiisa weerarka ka hor, tallaabooyinkee (haddii ay kuwa jiraan) ayay qaadeen sida la xidhiidha ogaanshahaas iyo haddii ay jireen wax tallaabooyin dheeraad ah ee ah in wakaaladaha ay qaadi lahaayeen si ay uga hortagaan weerarka; iyo
- (c) haddii ay jireen wax caqabado ah ee quseeyo wakaaladaha qeybta Gobolka oo usu keenayo ama wadaagayo warbixinta la xiriirto weerarka, ama ku dhaqmayo warbixin noocaas ah, oo ay ku jiraan caqabadaha sharciga; iyo
- (d) haddii ay jireen wax diirad saarid aan ku habooneyn, ama mudnaan dajinta, illaha ka hortaga argagaxisada oo wakaaladaha qeybta Gobolka quseyso weerarka ka hor.

#### **4 Arimaha xiliga oo natijjooyinka la raadiyay**

- (c) haddii wakaaladaha qeybta Gobolka quseyso ku guuldareystaan inay filanayeen ama qorsheeyaan weerarka ay sababtayka fiirsasho aan ku habooneyn ee illaha ka hortaga argagaxisada ama ahmiyadaha halisaha kale ee argagaxisada; iyo
- (d) haddii wakaalad walboo qeybta Gobolka ku guuldareystaan inay buuxiyaan heerarka loo baahanyahay ama ay haddii kale qalad ku jireen, haddii guud ahaan ama qeyb ahaan; iyo
- (e) arimo kaloo kale ee quseeyo ujeedada weydiinta, ee illaa iyo xad muhiim u ah bixinta warbixinta dhameystiran.

## **5 Arimaha xiliga oo tallooyinka la raadiyay**

- (1) Weydiinta waa inay sameysaa tallooyin walba ee ay u tixgeliso inay ku haboontahay sida soo socota:
- (a) haddii ay jiraan wax horumar ah xaga maclummaad ururinta, wadaagista, iyo dhaqamada falanqeenta oo wakaaladaha qeybta Gobolka oo ka hortagi lahaa weerarka, ama ka hortagi lahaa weeraro noocaas ah oo mustaqbalka, oo ay ku jiraan, laakiin kuma xadidna, qabashada wakhti habboon, ku filnaanshaha, waxtar lahaanta, isku xidhka shaacinta maclummaadka, wadaagida, ama barbardhiga u dhaxeeyo wakaaladaha qeybta Gobolka quseeya; iyo
  - (b) isbadeladee, haddii ay ku jiraan, ayaa ah in la fulliyo si sare loogu qaado wakaalada qeybta Gobolka quseysa, ama dhaqamada howlgalka, si loo hubiyo ka hortaga weeraro noocaas ah mustaqbalka; iyo
  - (c) arimo kaloo kale ee quseeyo kuwa kore, ee illaa iyo xadka lama huranka u ahbixin warbixin dhameystiran.

## **6 Xadadka baaxada awooda weydiinta**

## **7 Weydiinta waxay tixgelin kartaa baaritaanada kale ama dib u eegidaha**

Weydiinta waxay ku xisaabtami kartaa natijada baaritaan walba ama dib u eego arimaha quseyso xeerarkooda tixraaca, laakiin kuma xirno qaab walba oo gabagabada ama tallooyinka baaritaano noocaas ah.

## **8 Weydiinta waxay kala tashan kartaa shirkadaha kale ama dadka**

- (1) Weydiinta waxay kala tashan kartaa shirkadaha ama dadka kale, oo ay ku jiraan Baaraha Guud ee Sirdoonka iyo Amniga, haddii ay u tixgeliyaan in wadahadal inuu caawinayo si ay u qabtaan waajibaadyadooda.
- (2) Dowlada waxay filaneysaa in wedyiinta ay u xilsaareyso qof ama dad u qalmo oo ku haboon si ay u caawiyaaan weydiinta la macaamulkooda bulshooyinka Muslimka New Zealand, iyo in weydiinta ay kala tashaneyso bulshooyinkaas marwalboo ay u baahantahay inay sidaas sameyso si markaas looga saaro masuuliyadaheeda.

## **9 Qabashada Weydiinta**

Aruurinta weydiinteeda, weydiinta waxaa laga filanayaan inay tixgeliso cadeynta—

- (a) saraakiisha wakaalada quseyso iyo shaqaalah; iyo
- (b) dadka kale ee quseeyo, oo ay ku jiraan xubnaha bulshooyinka Muslimka.

## **10 Mabaadi'da weydiinta**

- (1) Maadada baahida loogu soo wargelinayo si wax ku ool ah arimaha lagu dajiyay xeerarkaan tixraaca, weydiinta waxaa lagu jaheeyay inay ku dhaqanto awoodaheeda iyo waajibaadyada oo soo wargeli qaab noocaas ah sida loo yareeyo suurtogal nimada inay tahay nidaamyadeeda ama wargelinteeda, ama qeyb walba oo iyada ah, waxaa lagu isticmaalaa shaqsi walba ama koox (oo ay ku jiraan shaqsiga lagu eeddeeyay xadgudubyada la xiriiro weerarka) si sare loogu qaado howlaha sharci darada ah, ama haddii kale waxyeeleynta danaha bulshada.
- (2) Arimaha weydiinta lagu dalacay ee baaritaanka sida tooska ah ula xiriiro dhaqamda howlgalka quseeyo wakaaladaha qeypta gobolka, oo ay ku jiraan wakaaladaha sirdoonka iyo amniga, kaas oo ah ama ahaanayo qarsoodi danaha bulshada si markaas loo hubiyo badbaadada bulshada, si looga fogaado naceybka xiriirada caalamiga ah ee Dowlada New Zealand iyo ku aaminida warbixinta Dowlada New Zealand ee ku saleysan qarsoodi, iyo joogteynta sharciga.
